ANNOUNCEMENT IN RELATION TO RESIGNATION OF A DIRECTOR

Mr. Zhang Junxiong (“**Mr. Zhang**”), a director (the “**Director**”) of CSSC Offshore & Marine Engineering (Group) Company Limited (the “**Company**”), submitted a written resignation to the board (the “**Board**”) of Directors of the Company on 3 September 2024 to resign from the positions of the Director of the eleventh session of the Board and a member of the Strategy Committee of the Board due to his retirement. His written resignation shall take effect upon its delivery to the Board (that is, 3 September 2024). The Company will conduct a by-election of the director(s) in accordance with the statutory procedures.

The Board would like to express its sincere gratitude to Mr. Zhang for his outstanding contribution to the business development and corporate governance of the Company during his tenure of office.
